Timeline Performance

From the time that a submission is accepted for review, the CADTH pharmaceutical review programs strive to issue an embargoed CDEC (CDR) or pERC initial (pCODR) recommendation within a 180-calendar-day timeline. In 2017–2018, CDR met the performance measures 100% of the time and pCODR 100% of the time.

Number of Policy & Practice Changes Informed by CADTH Products The Newfoundland and Labrador Department of Health and Community Services announced **new investments in home hemodialysis machines to allow patients in the province to receive home-based dialysis**. The decision was based, in part, on recommendations from CADTH's Optimal Use project.

CADTH opioid and pain evidence has helped inform **PEI's new action plan to help** prevent opioid overdoses and deaths, and has been used extensively in continuing education sessions in NB, which have involved over 400 clinicians to date.

Docusate was removed from formularies in eight jurisdictions as a result of CADTH's evidence.

CADTH's Rapid Response Report Airway Pressure Release Ventilation for Acute Respiratory Distress Syndrome was used to **inform a clinical decision support tool in a BC health authority**.

CADTH evidence supported decision-making for the Nova Scotia Health Authority on whether to incorporate closed-system transfer devices in its design of a chemotherapy preparation area within a new medical facility. 1,500+ Tools Developed 79
